IMPLEMENTATION OF PRESSURE MANAGEMENT IN THE DURBAN CBD

Notice is hereby given that Municipality's Non-Revenue Water Branch is introducing an Advanced Pressure Management in the Durban CBD. eThekwini Water and Sanitation (EWS) has embarked on an aggressive programme to reduce the unacceptably high levels of water losses in the city. On average, the CBD area looses approximately 10 million litres/day through leaks, illegal connections

and other losses. This amounts to roughly R10 million/year in lost revenue. The Durban CBD currently has an average supply pressure of 60 of service well in excess of recommended supply pressures. This has a direct impact on the high levels of leakage currently experienced in the CBD. There will be immediate savings if the pressure is lowered for all or for part of the day. EWS commissioned an investigation into the possible benefits of pressure control, which was followed by more detailed investigations (including fire

demand test scenarios, field tests and site visits to 185 buildings with 10 or more stories) and the scheme has been accepted for implementation. In summary, the implementation of advanced pressure management will take place as follows:

Phase 1: The construction of a Pressure Reducing Valve (PRV) Station to control the CBD pressures and commissioning of the PRV station without any form of pressure control Phase 2: Reduction of offpeak pressures by 10m Phase 3: Reduction of offpeak pressures by 20m

Phase 4: Reduction of offpeak pressures by 25m **Phase 5:** Reduction of peak pressures by 10m and off-peak pressures by 25m. The number and location of potentially affected con sumers has already been determined for each of the above steps. Those consumers who reside in buildings higher than 10 stories will need to ensure their booster pump and roof-top storage systems are in working order in compliance with the prevailing Bylaws. Each affected consumer will receive written advance notice of the exact dates and time of implementation of the supply

change, and given sufficient time to ensure they will not be affected by these changes. The implementation of each of the phases will take place over an extended time period, with the reaction of the system and impact on consumers being carefully monitored and evaluated before proceeding onto the next phase. The proposed activity will result in low significance impacts during the construction phase. The operational phase impacts are long term and will result in a significant reduction in leakage, without tangibly affecting the service supply currently

enjoyed by CBD consumers as long as the plumbing in the building is functioning properly and in compliance with the Bylaws.
