IMPORTANT NOTICE TO ALL PROVIDERS OF GOODS TO ETHEKWINI WATER AND SANITATION/ ETHEKWINI CLEANSING AND SOLID WASTE

In terms of the Municipal Supply Chain Regulations, as defined in section 168 of the Local Government: Municipal Finance Management Act, 2003 (Act No. 56 of 2003), all local Authorities are required, for purchases in excess of R30 000,00 inclusive VAT, to advertise for a period of at least seven calendar days a "request for quotation" on the website and on an official notice board of municipality. As result of this Act, Water and Sanitation as well as Cleansing and Solid waste will, with effect from Monday 18 September 2006, be applying this process for the purchase of all Stock and Non Stock materials. This means that from 18 September 2006

the buyers will be calling for individual companies for quotes. Companies will require to access the Council Website 'www.durban.gov.za', click on the "Goods and Services Quotations" link, which will take them to the "Request for Quotations System (RFQ)site", on which all request for quotations from Water and Sanitation/ Cleansing & Solid Waste can be viewed. Should Companies be interested in quotations they must print the RFQ form from off the internet, complete the form accordingly and fax the form back to the specified fax number. For companies without internet facilities, the RFQ notice will be displayed

on the Water and Sanitation notice board at 3 Prior Road, Durban. Suppliers wishing to quote against any specific RFQ should approach the Contracts and Material staff on the 2nd floor of the Water and Sanitation building, to print out the necessary documents. The completed RFQ document must be faxed back to the specified number. Please note that **only quotations faxed and on the specified Request For Quotation form, printed from the web, will be accepted.** All other forms of quotations will be disqualified.
