Delays in obtaining town planning approvals and also changes in Government Regulation & Law i.e. from LFTEA to PDA and now SPLUMA which necessitate approval. 4. Compliance with new Environmental Legislations i.e. WULA (Water Use Licence), necessitated additional studies to comply with the Act.
